### **DEFINITIONS:**

**Residential:** A customer is any water user with a ¾" inch water meter that serves only one (1) dwelling.

**Commercial Class 1 (3/4" meter only):** A customer serving only one (1) dwelling, business office, facility, or operation.

**Commercial Class 2 (3/4" meter only):** A customer serving more than one (1) dwelling, business office, facility or operation and/or providing water to multiple end users (e.g. RV parks, boat docks, two or more cabins).

**Caution:** A residential type water user that serves more than one (1) dwelling with a single ¾" meter is considered Commercial Class 2.

**Note:** A dwelling is defined as a shelter in which people live.

### **POLICY OF LATE CHARGES AND CONNECT FEES**

**KETCHUM VOLUNTEER FIRE DEPARTMENT (KVFD) CHARGE:** Effective August 1, 2006 a \$1.00 monthly charge will apply to all KPWA accounts.

**Customer Deposit:** Every customer account is required to pay and maintain a minimum \$100 deposit.

**Late Charge:** Water and sewer bills are due upon receipt in the month they are postmarked. Payment must be received in the Ketchum Public Works Authority ("KPWA") office no later than the 16<sup>th</sup> day of that month by 4PM, or a late charge will be added in the amount shown on the bill in the block marked "After Due Date". Late fee shall be 15% of the total due.

**Disconnect:** If payment is not received by the 25<sup>th</sup> of the monthly 4:00PM, the customers meter is subject to disconnect on the 26<sup>th</sup> of that month. KPWA does not disconnect service on Fridays or the day before a holiday.

**Connect:** To connect, the customer must pay the original amount of the bill, all late charges, an \$80.00 connect fee.

**Abandoned Water and Sewer Service:** When water or sewer service has been inactive (no minimum bill has been paid and/or water purchased or sewer paid) for a twelve (12) month period, the service will be disabled by removing the water meter and securing the meter loop and/or removing services altogether. The account will be closed. To restore or obtain service at this location, a new application shall be required with fees being the same as new service (tap, deposit, and connect fees).

**After Hours Work Request Call-Out:** KPWA charges minimum of \$70.00 for after hours Call-Out and \$35 per hour thereafter per operator. This cost does not apply when the KPWA manager declares the Call-Out to be an EMERGENCY. After hours is any labor completed after 4PM Monday thru Sunday.

**Return Check Policy:** A \$50.00 cash charge shall be assessed for all checks returned to KPWA.

**NO EXCEPTIONS TO THIS POLICY:** ANY DISAGREEMENT WITH THIS POLICY MUST BE PRESENTED AT A REGULAR SCHEDULED KPWA BOARD OF TRUSTEES MEETING. THOSE MEETINGS ARE HELD THE SECOND THURSDAY OF EACH MONTH AT 5:00PM, UNLESS OTHERWISE POSTED AND ADVERTISED. IF YOU WISH TO PRESENT A DISAGREEMENT, PLEASE CONTACT THE KPWA OFFICE SEVEN DAYS BEFORE THE MEETING SO YOU CAN BE PLACED ON THE AGENDA.
